Personal data that we process

VI Technologies BV processes your personal data because you are using our services and/or because you have provided your personal data to us.

Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors who are below the age of 16, unless they have permission from parents or guardians. The purpose for which and the basis on which we process personal data

Personal data retention period

VI Technologies BV will not retain your personal information longer than strictly necessary to achieve the purposes for which your data is being collected.

Sharing personal data with third parties

VI Technologies BV shares your personal data with service providers engaged by us if this is necessary for the correct and efficient execution of the work and to comply with any legal obligation. These companies can be located in the Netherlands, in Europe, but also outside Europe. We conclude a processor agreement with companies that process your data on our instruction to ensure the same level of security and confidentiality of your data. VI Technologies BV remains the responsible party for these processing operations. VI Technologies BV only provides your personal data to other third parties with your express permission.

Cookies, or similar techniques, used by us

VI Technologies BV uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. VI Technologies BV uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website perform well and to optimize the site. In addition, we place cookies that keep track of your browsing habits so that we can offer customized content and advertisements.

View, modify or delete data

Please black out your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN: social security number) in the copy. This is for the protection of your privacy. We will respond to your request as soon as possible and within four weeks at the latest.
